Significant Events and/or Alarms

- On January 3, 2017 I received a denial from the State of MI reference our application for the Volunteer Fire Assistance Grant
- On January 6, 2017 SFD was dispatched to a structure fire at 1695 21 Mile Road with our automatic aid partners including a Sand Lake Engine, Kent City Tender, and an Algoma Tender. Arrival found a large outbuilding burning. SFD executed a quick knock down of the fire and our auto aid partners were disregarded.
- On January 9, 2017, an agreement was confirmed with the American Red Cross and the Smoke Detector Install program was officially authorized. Since this date all of the preparatory planning has been initiated including a media release, and posting to the Township website. Print media has been produced including a Tri-Fold brochure, Flyers, and an overall execution plan. It is anticipated that this will be a 12-18 month project. Installation days are being planned for Tuesdays and Thursdays both AM & PM (0700-1600 hours). As demand requires, other weekdays may be added, including one or two Saturday AM sessions (not in March). Detector install guidelines have been developed and will be reviewed by all members participating in the project.
- On January 10, 2017, received the resignation notice of FF Zachary Grutter
- On January 10, SFD responded to a motor vehicle accident on Simmons north of 20 Mile Road. Mutual aid was provided by Cedar Springs and Sand Lake FD. An adult female suffered serious injuries and was transported to the hospital.
- o After a very busy month of December for alarms, January was above normal too with 40 alarms.
- On January 25, the new Genesis battery operated rescue tools arrived. These tools were installed on Engine 1. It is amazing how much smaller space these tools absorb in the compartment and yet provide far superior cutting forces. The old tools have been listed for sale on some social media accounts for \$ 5,000.00. The

Genesis vendor recommends trying to sell here versus a trade in value. However, if they do not sell here as listed, the vendor says he will still make a trade in offer at a later date.

- On January 27, Chief Drake and the City of Cedar Springs City Manager Womack and Fire Chief Fraser met to discuss the proposal of contracting medical alarms (priority 1 & 2) east of US 131 with the city. Further discussion to be planned.
- New pumper/tender: currently working on the third version of the truck build specs from the vendor. Anticipating a possible March RFP release after consultation with the Board
- Station coverage was provided for the full time position

 - January 18, 2017, FF Schievink, 4.5 hours, sick time
