Significant Events and/or Alarms

- On March 1, 2017 Chief Drake attended the Southeast Michigan Fire Chief Conference and Expo.
- On March 2, 2017 FF Schievink provided 7 hours of station coverage and 9 hours on March 3, 2017 for DC Paige.
- On March 8, West Michigan was blasted with strong, hours long sustaining winds over 50 mph.
 As compared to our neighbors to the south, SFD made out easy with only 3 alarms for weather
 related service. Unfortunately, one primary line failure resulted in a road closure and "baby
 sitting" the downed primary power line for Consumers Energy by SFD for almost 12 hours.
- On March 15, 2017 SFD hosted the monthly meeting of the Kent County Fire Chief group.
- On March 18, 2017 a meeting was conducted to educate all personnel attending the Live Burn Training scheduled for March 25th on the expectations, limitations, and requirements of all participants as required by NFPA 1403 and MIOSHA standards.
- On March 25, 2017, the razing of the training house at 16889 White Creek commenced at 0800 hours. Assistance with personnel and/or apparatus was provided by Alpine, Algoma, Cannon, Plainfield, Sand Lake, Sparta, and Spencer Fire Departments. Breakfast sandwiches and refreshments were provided by 1-800 Board Up, a local vendor. Most of the mutual aid companies were released by 1200 hours. These departments assisted with the successful exposure of new personnel to four separate room fires in the structure before it was allowed to burn to the ground. SFD participation was eight personnel.
- On March 27, 2017 Chief Drake provided a safety presentation to 30 EnGede participants at Cedar Springs Red Hawk elementary
- On March 29, 2017, SFD hosted the quarterly meeting of the North Kent County Fire Chief group (Departments north of Ten Mile) to discuss regional interests.
- Overall, March 2017 was an extremely busy month again, even more so than January 2017. SFD was able to mitigate all the alarms with minimal mutual aid and zero "turfed" alarms. In addition, on four different dates in March, SFD responded to simultaneous alarms.
- The free smoke detector program netted zero inquiries or installs this month. SFD is seeking to obtain a recurring notice in the Cedar Springs Post about the program.
