RESOLUTION NO. <u>18-12</u>

RESOLUTION TO APPROVE BALLOT PROPOSAL FOR SUBMISSION TO ELECTORS OF ORDINANCE NO. 18-4-Z AMENDING THE SOLON TOWNSHIP ZONING ORDINANCE

WHEREAS, on April 10, 2018, the Township Board of the Township of Solon adopted Ordinance No. 18-4-Z, which, among other matters, would create a new AR-2 Low Density Agricultural Residential District and would rezone various lands formerly in the AR District to the new AR-2 Low Density Agricultural Residential District;

WHEREAS, on April 19, 2018, the notice of adoption of Ordinance No. 18-4-Z was published in the *Cedar Springs Post*, a newspaper of general circulation within the Township;

WHEREAS, on April 24, 2018, the Township Clerk received a Notice of Intent to file a petition for submission to the Township electors of Ordinance No. 18-4-Z in accordance with the requirements of Section 402 of the Michigan Zoning Enabling Act, Act 110 of the Public Acts of Michigan of 2006, as amended;

WHEREAS, on May 18, 2018, petitions requesting the submission of Ordinance No. 18-4-Z to the Township electors were submitted to the Township;

WHEREAS, the Township Clerk has determined that the petitions were signed by registered Township electors residing in that part of the Township outside the limits of cities and village in a number greater than 15% of the total number of votes cast in the Township for all candidates for governor in the election held on November 4, 2014;

WHEREAS, the petitions are in proper form and content, were submitted within 30 days after publication of the notice of adoption of Ordinance No. 18-4-Z and otherwise comply with the requirements of said Section 402; and

WHEREAS, the Township Board desires to approve a ballot proposal for the submission of Ordinance No. 18-4-Z to the Township electors in accordance with the submitted petitions, and to determine a date for the election with respect that ballot proposal.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The question of whether Ordinance No. 18-4-Z shall be approved shall be submitted to the electors at the November 2018 general election to be held on Tuesday, November 6, 2018, a date approved for elections pursuant to Section 541 of the Michigan Election Law.

2. The ballot proposal to be submitted to the electors shall be in the form attached hereto as Exhibit A.

3. The Township Clerk is authorized and directed to make the necessary arrangements to deliver a certified copy of this resolution to the Kent County Clerk as soon as possible, but in any event not later than 4:00 p.m. on August 14, 2018, and to take such other action as may be necessary or useful in the scheduling of the election.

4. The last day of registration for the November 6, 2018 general election shall be Tuesday, October 9, 2018. Pursuant to Section 498(1) of the Michigan Election Law, the Township

Clerk is directed to be at the Clerk's office located at the Solon Township Hall, 15185 Algoma Avenue, NE, Cedar Springs, Michigan, within the Township, on Tuesday, October 9, 2018, from 9:00 a.m. to 5:00 p.m. to receive applications for voter registration.

5. The Township Clerk is directed to provide for publication of the Notice of the Last Day of Registration, which is hereby approved substantially in the form attached hereto as Exhibit B, with such publication to be not less than seven days before the last day of registration, and in addition, to provide for publication of the Notice of Election, which is hereby approved substantially in the form attached hereto as Exhibit C, with such publication to be not less than seven days before the day of the election. The publication of the notices shall be made in the *Cedar Springs Post*, which is hereby determined to be a newspaper of general circulation in the Township reaching the largest number of persons to whom such notices are addressed.

6. The Township Clerk is authorized and directed to follow all applicable procedures required by the Michigan Election Law for the general election.
