# **Outside of Station Functions, Significant Events, Alarms:**

- On 7-31-20 Deputy Chief Paige tendered his resignation from the full time position to accept a
  position with a local excavating company. He is keeping his rank and part time status with the
  department.
- As a result of the resignation stated above, the position was posted internally requesting those interested to respond by August 7, 2020. More to follow next month.
- A few members of the team have been troubleshooting the dry hydrant at Lime Lake for poor flow. Solutions are being examined, and considered.
- Annual Kid's Day at Duke Creek was on 7-8-2020. Team members sprayed some water from the lake and displayed the apparatus. This event was cut short due to an alarm.
- Full Time position coverage by FF Schievink on 7-27-20

On July 2, 2020 SFD responded with mutual aid from Kent City FD to Long Lake Park on a report
of a pulseless person removed from the waters at the swim area in the park. Emergency
personnel were able to regain a pulse at the scene and transport the patient to the hospital.
Unfortunately, the victim did not survive this incident.
